1. The Principal, at the request and with the approbation of the Student hereby assigns unto the New Principal the said recited Indenture for Articles of Clerkship, and all benefit whatsoever to be had or made thereof, and also all the right, interest, property, profit, advantage, claim and demand whatsoever to be had or made to the New Principal from henceforth of the Student during the residue of the Term, as established pursuant to the said recited Indenture for Articles of Clerkship;
2. The New Principal covenants that he or she will at all times during the residue of the Term, to the best of his or her ability, instruct the Student as an Articled Clerk in the practice of a Solicitor of the Supreme Court of Newfoundland;

3. The Principal and the New Principal severally covenant that each, at any time after the expiration of the Term, will certify their respective times of service by the Student under Articles of Clerkship, and will use their best means and endeavours at the request, and expense of the Student, to cause and procure the Student to be admitted as a Solicitor of the Supreme Court of Newfoundland, provided that the Student shall have well, faithfully, honestly and diligently served the Principal and the New Principal respectively in accordance with the Articles of Clerkship.
